accordingly --- Whereupon the Said Aaron Jordan in custody and in his own proper per-
son says that he cannot gain say the p^{er} his action and nor but that the debt and is yet due and
unsatisfied Wherefore the Said p^{er} prays Judgment for his debt and his costs and damages sus-
tained by reason of the detaining the same debt --- therefor it is considered by the Justice
here the seventeenth day of November and Year. One thousand Seven hundred and twenty four that the Said George
Full Recover against the Said Aaron Jordan in custody as of as well the Sum of One thousand pounds of
tobacco his debt and as also the Sum of ~~the~~ hundred and twenty pounds of tobacco by the Court here adjudged unto
for his costs and damages sustained by reason of the detaining the same debt to him to be adjudged & that of
money & and afterwards in the Same Court the said Aaron Jordan is committed by the Justice thereof into
the custody of the Sheriff of Somerset County there to remain until such time as the p^{er} of his debt and costs
and shall be there off fully satisfied &c
