Also the said Master Driskill Garnishee of the said Timothy Bloodworth appears in his own proper person and says he cannot gain say but that he has of the rights and Credits of the said Timothy Bloodworth in his hands to the value of Seven teen Shillings and <sup>the</sup> pence so as aforesaid attached, nor but that the same ought to be condemned in his hands for the use of the said Patrick Simpson as of the rights and Credits of the said Timothy Bloodworth which the said Elft do not gain say

Whereupon the said Thomas Saranore, Jacob Couch, John James, Solomon Turpin and Samuel Alexander Garnishees of the said Timothy Bloodworth <sup>in their</sup> own proper persons appears and voluntarily takes their Oath with Consent of the Elfts attorney aforesaid that they had notice of the Effects of the Defts in their hands at the time of Exiging the attachment aforesaid nor at no time since thereupon said Thomas Saranore, Jacob Couch, John James, Solomon Turpin and Samuel Alexander Garnishees aforesaid were discharged

Whereupon the Court adjourns until the next next day of August being the thirtieth day of the same Month And Down One thousand Seven hundred and twenty three on which day and year the Court set againe and then and there found the said Patrick Simpson by his attorney aforesaid - And thereupon the said Curriell Johnson, Ebenezer Cottman, ~~William Moor~~ James Driskill John Davis, William Irish John Brady, Alex Shiles George Goddard, Charles Young

Naomie Shiles, Thomas Horne, Christopher Nutton ~~William Moor~~ Thomas Brewster Oliver Such Thomas Caldwell, James Smith, John Anderson James Goshue and Sarah Eric Garnishees aforesaid <sup>formally</sup> solemnly called come not, nor show Cause why <sup>they</sup> But make default nor does any other person for them appear to show Cause to the contrary

Whereupon the said Patrick Simpson by his attorney aforesaid says that the several Sums so as aforesaid Confessed by the said William Moor Dudley Cook and Master Driskill, as also the several Sums aforesaid so as aforesaid attached in the hands of the said Curriell Johnson, Ebenezer Cottman, ~~William Moor~~ James Driskill, John Davis, William Irish John Brady Alex Shiles, George Goddard, Charles Young Naomie Shiles Thomas Horne, Christopher Nutton Timothy Roads Thomas Brewster, Oliver Such, ~~Thomas Caldwell~~ James Smith, John Anderson, James Smith, Goshue and Sarah Eric Garnishees aforesaid, as also the several goods aforesaid attached in the hands of Charles Ballard, and Naomie Shiles, all which Sums aforesaid Confessed and attached as the rights and Credits of the said Timothy Bloodworth may be condemned in the hands of the several Garnishees <sup>hand</sup> aforesaid towards Satisfying unto the said Patrick Simpson as well the sum of Seventy two pounds twelve Shillings Debt and <sup>Interest</sup> Interest as also One thousand pounds, both Costs of Suite

Therefore it is considered by the Justices here the thirtieth day of August And Down One thousand Seven hundred and twenty three that the said Sum of Two Shillings and two pence part of the Sum: so attached and Confessed before mentioned in the hands of the said William Moor as of the rights and Credits of the said Timothy Bloodworth towards Satisfying unto the said Patrick Simpson his Debt and Costs aforesaid as also the Costs accruing upon the writ of attachment aforesaid and that the said Patrick = (Simpson)
