Therefore it is Considered by the Justices here the Sunday and Year aft that the said Sum of Eight
Shillings and Six pence Part of the Sum so attached and Confessed be Condemned in the hands of the said
Dudley Boock as of the Rights and Credits of the said Timothy Bloodworth towards Satisfying unto the
said Gabriel Simpson his debt and Costs aft as also all Costs accruing upon the writ of attachment aft
and that the said Gabriel Simpson ^{have} his Execution against the said Dudley Boock according to act of
assembly - Now the Garnishee Dudley Boock voluntarily takes his Oath that he hath no more
of the Effects of the Deft in his hands than what he has Confessed

Therefore it is Considered by the Justices here the Sunday and Year aft that the said Sum
of Seventeen Shillings and nine Pence so as aft attached and Confessed be Condemned in the hands of
the said Major Driskill as of the Rights and Credits of the said Timothy Bloodworth towards Satisfy-
ing unto the said Gabriel Simpson his debt and Costs aft as also all Costs upon the ^{writ of} attachment aft and
that those of the said Gabriel Simpson have his Execution against the said Major Driskill according
to act of assembly

Therefore it is Considered by the Justices here the Sunday and Year aft
that the said goods to the value of forty four pence seven Shillings and ten pence so as aft attached
in the hands of May Charles Ballard, be Condemned as of the Rights and Credits of the said Timothy Blood-
worth towards Satisfying unto the said Gabriel Simpson his debt and Costs aft as also all Costs accruing
upon the writ of attachment aft and that the said Gabriel Simpson have thereof his Execution according
to act of assembly

Therefore it is Considered by the Justices here the Sunday and
Year aft that the said goods to the value of four pounds Eight Shillings so as aft attached in the hands
of Naomi Miles, be Condemned as of the Rights and Credits of the said Timothy Bloodworth towards
Satisfying unto the said Gabriel ^{Simpson} his debt and Costs aft as also all Costs accruing upon the writ of
attachment aft and that the said Gabriel Simpson have thereof his Execution according to act of assem-
bly
