And the said Henry Alexander in his own proper Person comes and Defends the force and Injury when &c and says that he cannot gain say the Plaintiff's action aforesaid against him brought nor can he say But that he was indebted unto the said Robert Woods in his Lifetime the aforesaid Sum of four hundred and thirty pounds of Tobacco nor can he say but that the said Catherine &c of the same Robert ought to recover her damages by Breach of the Premises aforesaid to four hundred and thirty pounds of Tobacco and Costs of Suite against him which the said Plaintiff does not gain say &c Therefore is considered

By the Court here the twentieth day of November Anno Domini One thousand Seven hundred and twenty four That the said Catherine Woods &c of the same Robert Woods do recover against the said Henry Alexander as well the Sum of four hundred and thirty pounds of Tobacco her damages aforesaid in form aforesaid Confessed as also the Sum of Two hundred and forty two — pounds of Tobacco by the Court here as judged unto her for her Costs and Charges by her about her Suite in this behalf Said out and Expended and the said Plaintiff Merely &c
