John Cope, Henry Seferid, Moses Fenlon, William Miles, Daniel Cudery, Mout *Edm* Robert Hill Charles Townsend, James Hall, James West, who being duly Sworn to say the truth in the Oath do say that the said William Breaton is guilty of the Crime as above imposed on him, in manner and form as the said Thomas and Mary above against him hath complained and do assess the damages of the said Thomas and Mary his wife by Occasion of the Crime as above to the sum of Six hundred pounds of tobacco, and one pound of cost besides their costs and charges in this behalf said out and Expended

Therefore it is Considered by the Justice here the thirtieth day of April Amd. Dowd. One thousand Seven hundred and twenty three *Edm* that the said Thomas Breaton and Mary his wife be sworn against the said William Breaton as were the sum of Six hundred pounds of tobacco ~~by the Court~~ here adjudged to be their damages by Occasion of the Crime as above in sum as aforesaid as also the sum of *Edm* of tobacco by the Court here adjudged unto them for their costs and charges by them about their suits in this behalf said out and Expended and do do in many *Edm*
