Rosa Magee of Stogney Parish if she shall be found in his Bailiwick and he should safe Keep so that he
might have her Body Before the Justices of his Lordships County Court of Sommersett to be hold at Discrey
Next the third Monday of March next to an hour unto his Lordship Concerning a Petition presented against her
found and that they of his should not fail
At which said third Tuesday of
March to wit the Nineteenth day of the same month Amd. Dow. One thousand seven hundred and twenty
two Being the day of the return of the said Writ Comers the Sher. of Sommersett County and makes return
that of Edward bid - - - Legi of Joseph M. for Sher.

Whereupon the said Sher. at his solemnly called brings not in the Body
of the said Rosa Magee But humbly Crays that day may be given him until Next Court to bring in the Body
of the said Rosa Magee to answer the Comifors above said which is granted

At which said next Court to wit the Eighteenth day of June Amd. Dow. One thousand seven hundred and
twenty three Comers the said Sher. and brings into Court the said Rosa Magee to answer. Whereupon the said
Rosa Magee being sett to the Bar is thereupon Instantly demanded how she would acquitt herself of the Comifors
and Says that of the Comifors she is guilty thereof, and Submits to the Mercy of the Court. and Says that a certain
Robert Canady is the father and Beggetter of the Child she stands Criminated for - But for as much as the said Rosa
Magee had not wherewith all to pay her fine for the fact of nor no person would do the same for her

Wherefore it is Considered by the Justices here that the said Rosa Magee be had to the Publike Whipping
Post and there to be whipt on the Bare Back with fifteen Lashes well laid on while the Blood appear thereupon
Command is given to the Sher. of Sommersett County that he do there of Immediate
Execution according to the Judgment of law by whipping the said Rosa Magee at the Publike Whipping Post with
fifteen Lashes on her bare Back well laid on while the Blood appear and afterward the Sher. to return that
he has done the Execution of the Judgment as aforesaid Comanded Whereupon for as much as the said Rosa
Magee is absent It is Ordered that the Justice of the Peace for the County that arrived by
action of the Comifors aforesaid
