

vs. Levi Gale

Command was given to the Sher. of Somerset County that he should take Alexander Magakere for Magakere late of Row by Carish York if he should be found in his Bailiwick and him should safe keep so that he might have his body before the Justices of his Lordship's County Court of Somerset to be held at Widing Creek the third Wednesday of June then next to answer unto Levi Gale of ap'ts a of his pay upon the Case p^o. And that there of he should not fail p^o.

And whereas the said Levi Gale in his proper person complains that whereas the aft Alexander the tenth day of October One thousand Seven hundred and twenty two at Carish aft within the Jurisdiction of this Court was indebted unto the aft Levi in the Sum of two pounds Seven Shillings for the like Sum by the said Alexander of the said Levi to see that time past and so thereof being indebted the said Alexander in Consideration thereof the day and year aft at Carish aft within the aft Jurisdiction upon himself assumed and to the said Levi then and there faithfully promised that he the said Alexander the aft Sum of two pounds Seven Shillings to the aft Levi when afterwards he should be therunto requested he would well and faithfully pay and Content Now the aft Alexander his Promise and assumption aft in form aft made Little regarding but Clotting and fraudulently Intending the said Levi in that Court to defraud and deceive the aft Sum of two pounds Seven Shillings or any Part thereof altho' therunto Requested the tenth day of April One thousand Seven hundred and twenty three and often afterwards to the said Levi hath not paid or Contented but the same hitherto to pay hath altogether refused and still doth refuse whereby the said Levi says he is the worse and hath damage to the Value of Six pound Court money of many lands and there of brought this Suit p^o - Levi Gale Complainant vs. Alexander Magakere Defendant

At the which said third Wednesday of June to witt the Eighteenth day of the same Month Aft. Dow. One thousand Seven hundred and twenty three Being the day of the return of the said Writ Comers the said Levi Gale in his own proper person aft and the Sher. of Somerset County aft to whom the foregoing Writ was directed His wife Comers and makes to him thereof to the Court her Evidence in these words following viz -

Whereupon the said Levi Gale in his own proper person as aft Crays that for as much as he has Complied with the Law in Order to an attachment he may have Judgment against the said Alexander Magakere for his damages aft by way of attachment according to act of assembly p^o.

Whereupon for that it seems to the Court her that the said Levi Gale has Complied with the Law as alledged; -

Therefore it is considered by the Justices her that the Eighteenth day of June Aft. Dow. One thousand Seven hundred and ^{the day of the return} ~~eighteen~~ ^{thirteen} that the said Levi Gale recover against the said Alexander Magakere a wole the sum of two pounds Seven Shillings his damages aft by Occasion of the Executions aft as all Costs and Charges by the said Levi paid and Expended about his Suit by way of attachment against the goods Chattels rights and Credits of the said Alex. Magakere according to act of assembly in such Case made and Provided p^o.
