By virtue of the Within Writt so directed to the I have attached in the hands of the Several persons in a Schedule to this writt annexed mentioned the Several Sums of money to their Several Names annexed as the goods and Chattels of the Within Named William Gilchrist and Thomas Brown I have also made known unto the said Several persons that they be and appear before the Justices within Mentioned to shew Cause if any they have why the said Several Sums of money so attached in their hands as the goods and Chattels of the said William Gilchrist and Thomas Brown should not be condemned and Execution thereof made before the said Justices. For good and Lawfull reason of my Bailiwick as by the Within Writt I am Comanded so answer

Richardson, Edward Bennett, William Hopkins and William Comiter garnishes aforesaid all his severally solemnly called Come not nor shew Cause why &c. but makes default, whereby the said Sums remain there of wholly undefended &c.

Whereupon the said Robert Martin by his attorney aforesaid pray that the several Sums of money aforesaid so as aforesaid attached as the rights and Credits of the said William Gilchrist and Thomas Brown may be condemned in the hands of the said William Whittington Thomas Comiter, George Furnace, William Richardson Edward Bennett William Hopkins and William Comiter, garnishes aforesaid towards Satisfaction of the said Robert Martin Damages and Cost aforesaid &c.

Therefore it is Considered by the Justices here the Eighteenth day of June And Done One thousand Seven hundred and twenty three that the said Sum of One pound fifteen Shillings and Nine pence so as aforesaid attached be condemned in the hands of the said William Whittington as of the rights and Credits of the said William Gilchrist and Thomas Brown towards Satisfying unto the said Robert Martin his Damages and Cost aforesaid and that the said Rob^t. Martin have his Execution thereof against the said William Whittington (according)
