as aforesaid may in Court appear and being so thereof Indebted the said Charles afterward to wit the day and year  
aforesaid at the place aforesaid in Consideration whereof upon himself did a sume and to the said Robert then and there did  
faithfully promise that he the said Charles the aforesaid One thousand three hundred and twenty Nine pounds of tobacco  
to the said Robert when he should be afterward thereto requested he would well and faithfully pay and  
content and altho the said Charles three hundred Eighty and Six pounds of tobacco free of the aforesaid One thousand  
three hundred twenty and nine pounds of tobacco to the said Robert he hath paid and satisfied his  
aforesaid Nine hundred forty and Three pounds of tobacco residue of the aforesaid One thousand three hundred twenty  
and nine pounds of tobacco the said Charles his promise and assumption aforesaid in form aforesaid made little  
regarding but plotting and fraudulently extorting the said Robert in that part craftily and subtilly  
to deceive and defraud the aforesaid Nine hundred forty and Three pounds of tobacco to the said Robert he hath not
