At which said third Tuesday of August next to with the twentieth day of the same month and Term. On the said Seven hundred and twenty three Comes the Sheriff of Somerset County and makes return there of Endorsed to the Court here viz. Summed of Joseph M^r Chester Sheriff

Whereupon appeared here in Court the Petitioner aft as also the said Orphan called John Warren and the Court having heard their severall allegations as well on the part of the Petitioner aft as on the part of the said Orphan, and having deliberated thereon. Thereupon the said John Warren by his agent ~~Delia~~ is bound by the Court unto Catherine Curnell Widow of Reg^t Thomas Curnell aft dec^d until he arrives to the age of twenty One year of age, he being seven teen years old last March, the said Catherine Curnell to teach the said John Warrens to read and write, and to give him a new Suite of Cloaths at the Expiration of his Servitude, and like wise to give him now at this time a Cow and Calf, the same Cow and Calf to remain with the Stock of the said Catherine Curnell until the Expiration of the Service aft, and then the said Catherine Curnell to deliver upon unto the said John Warren the said Cow and Calf with all her Increase &

It's thereupon Ordered by the Court that the said Catherine Curnell give Security for the performance of the Covenants aft. Whereupon the said Catherine Curnell with John Swire her Security present here in Court acknowledged themselves to stand and stand Justly Indebted Jointly and Severally unto the said John Warren in the Sum of twenty pounds Current money to be levied on their Bodge goods or Chattles Lands or tenements for the Use of the said John Warren in Case the said Catherine Curnell shall not comply with the Covenants aft.

To the worshipfull Justices of Somerset County in Court sitting the humble Petition of Adam Spence Ind^t most humbly sheweth, that whereas your worship's petitioner hath a negro woman named Jenny who hath been blind ever since your worship's Petitioner had her, not withstanding

your Petitioner not being desirous to be Burthened with the publick hath not heretofore petitioned to have her free, but in the last gust of weather your petitioner had a severe Brown down upon her which hath so Bruised her and Broke some of her Bones especially one of her thigh Bones, so that she is altogether Useless who hopes your worship will take it into your Judicious Consideration and Alleviate him from paying Taxes for her she being only a Charge to your petitioner and altogether incapable of doing any manner of Service and your worship's Petitioner as in duty Bound shall pray.
