Lazarus Maddug

Sarah Stevens an English Girl, by her Consent is bound by the Court unto Lazarus Maddug
of Coakamoak until she arrives to the age of sixteen years she being eight years old
the said Sarah Stevens to serve the said Lazarus Maddug the full term of time aforesaid -

Such security, Lawfull Service as he shall employ her in and about during the aforesaid servitude - In Consideration
of which Service so as aforesaid to be performed the said Lazarus Maddug promiseth by these presents to Learn the said
Sarah Stevens to read well in the Bible and to Knitt Sew and Spin and other housewifery, and to find and provide
for her sufficient meat drink washing Lodging and Bathing mete for her to have and ware during her servitude &c.

Whereupon it is Ordered by the Court that the said Lazarus Maddug give security for the performance of the
Covenants aforesaid. Thereupon the said Lazarus Maddug with John Broughton his security present here in Court
acknowledged themselves to Owe and Stand Justly Indebted jointly and severally unto the said Sarah Stevens
her heirs and assigns in the Summe of thirty pounds Curr^t money to be Levied on their Bodys goods and Chattles -
Lands or tenements for the Use of the said Sarah Stevens, In Case the said Lazarus Maddug do not Learn the
said Sarah Stevens to read well in the Bible, and to Knitt Sew and Spin during her servitude aforesaid and Likewise
to find and provide for her sufficient meat drink washing Lodging and apparell as aforesaid &c.

Joseph Dashiell } Now here at this day to witt the twentieth day of August and Dowd. One thousand seven hundred
Choose his guardian } and twenty three. Comes here into Court a certain Joseph Dashiell of Somersett County (Son in

law of Mag^r Joseph Maulester) and prays that he may have the Liberty of choosing a certain George Collier
as his guardian, he being being arrived to full years according to Law &c. which is granted him &c. thereupon
the said Joseph Dashiell makes choice of the said George Collier as his guardian &c. thereupon the aforesaid Joseph
Maulester present here in Court is Ordered to deliver up unto the said George Collier, Guardian of the aforesaid
Joseph Dashiell, all that part of the said Joseph Dashiell Estate that doth Justly Belong to him Out of
his Estate fathers Estate, that he hath in his hand &c. Whereupon it is further Ordered by the Court that the said
George Collier give good security for the secure Keeping of the said Joseph Dashiell Estate that shall be delivered
unto him by the said Joseph Maulester, and Likewise to return the Same to the said Joseph Dashiell when he
shall arrive to ^{full} years of according to Law to receive the Same

Thereupon the said George Collier together with Robert Collier his security present here in Court acknow-
ledged themselves to Owe and Stand Justly Indebted jointly and severally unto the said Joseph Dashiell his
heirs and assigns in the full and Just Summe of One hundred pounds Curr^t money to be Levied on their Bodys goods
or Chattles Lands or tenements for the Use of the said Joseph Dashiell his heirs and assigns In Case the said
George Collier doe not Preserve and securely Keep all that part of the said Joseph Dashiell Estate that shall
be delivered to him by the said Joseph Maulester, and Likewise to deliver the Same unto the said Joseph Dashiell
when he shall arrive to full years according to Law to receive the Same and Comply with the Law in that respect
Relating to guardians &c. then the above Recognizance to be void &c.
