Adams alio solemnly called doth not come but maketh default Likewise the aforesaid Thomas Thomas alio
solemnly called doth not come but maketh default whereby the said debt remaneth against the said debt
without further defense — Whereupon the Said Thomas Howell by his attorney aforesaid prayeth that judgment
Security according to act of assembly the several sumes of Money and to be five Sheep and ten Bushells of
Corn as of the lights and credits of the said William Kenney so aforesaid attached in the hands of Thomas
Howell William Cunalls, Charles Smith, John Adams and Thomas Thomas may be condemned in the hands of
the Said Thomas Howell, Thomas Howell, William Cunalls, Charles Smith, and John Adams towards
satisfaction of the Said Thomas Howell's damages and costs aforesaid — Whereupon Francis Allen gentl one of
the attorneys of this Court present here in Court undertaken for the Said Thomas Howell according to act of assembly
that in case the said William Kenney do at any time within a year and a day appear and make all or any part
of the sume of the Said Thomas Howell against him appear to be satisfied or otherwise to have been made
before the laying of this attachment that then the Said Thomas Howell shall make restitution to him the
said William Kenney of all or such part thereof as shall be made appear to be undue &c or that he the
Said Francis Allen will do it for him — Therefore it is considered by the Justices here the eleventh
day of June and now One thousand Seven hundred and twenty three that Said sume of ~~One~~ ^{One hundred} pounds eleven
shillings so aforesaid attached in the hands of the Said Thomas Howell as of the lights and credits of the said
William Kenney be condemned in the hands of the Said ~~William~~ ^{Thomas} Howell as of the lights and
credits of the said William Kenney for the use of the Said Thomas Howell towards satisfaction
of his damages and costs aforesaid and that there of he have his Execution according to act of assembly &c —

Therefore it is considered by the Justices here the same day and year last mentioned that the Said five
Sheep so aforesaid attached in the hands of the Said William Cunalls as of the lights and credits of the Said William
Kenney be condemned in the hands of the Said William Cunalls as of the lights and credits of the Said William
