

Bridge —

the New bridge by Maj: C. Ballard's Plantation at the head of Manoran, and from Manoran Bridge to Raymonds mill
James Strawbridge appointed Overseer in Manoran hundred from Richard Pinckett into the Main Load that Lead
from Kings Mills to the head of Manoran —

Merrick Ellis appointed Overseer of the Load in Wicomico hundred from Oster's Bridge to the Lower Ferry
over Wicomico, and white Haven River, and from the said Ferry to Maj: C. Ballard's Island —

Edward Dickenson appointed Overseer of the Load in Coakmoore hundred from Dividing Creek Bridge to the
end of your his Uncle's Bounds —

Rowland Beamin appointed Overseer in Coakmoore hundred to begin where Edward Dickenson Leaves of
and clear his former Quitts —

Peter Benton appointed Overseer of the Load from Dividing Creek Bridge to Harris' Bridge &c —

Ambrof Ligui appointed Overseer of the Load from Harris' Bridge to Thomas Breerton's Plantation &c —
