Some of ten Shillings and ten Bushels of Indian Corn so as aforesaid attached in the hands of the said John Adams as of the rights and Credits of the said William Kenney be condemned in the hands of the said John Adams as of the rights and Credits of the said William Kenney for the Use of the said Thomas Howell towards Satisfaction of his Damages and Costs aforesaid and that there be his Execution against the said John Adams according to act of assembly &c. — Therefore it is Considered by the Justices here the same day and Year Just men- tioned that the said Sum of five hundred pounds of Tobacco so as aforesaid attached in the hands of the said Thomas as of the rights and Credits of the said William Kenney be condemned in the hands of the said ~~William Kenney~~ Thomas Thomas as of the rights and Credits of the said William Kenney for the Use of the said Thomas Howell towards Satisfaction of his Damages and Costs aforesaid and that there be his Execution against the said Thomas Thomas according to act of assembly &c.

Philip Covington appointed Overseer in Manigh hundred from Estens Bridge along the Main load to the New Bridge by Majr Ballard's Plantation at the head of Manocan and from the head of Great Manigh to the head of Little Manigh and from his own house to Joy Hobbs —

William Bosman Senr appointed Overseer of the load in Manocan hundred, from the head of St. Peter's Creek to the New Bridge by Majr Ballard's Plantation at the head of Manocan, and from the head of Goose Creek to the New Church, and from the New Church into the Main load, that Leads from the head of St. Peter's Creek to the aforesaid New Bridge —

Matthew Dorman appointed Overseer of the load in Manocan hundred from Kings Mills to the New bridge by Majr Ballard's Plantation at the head of Manocan, and from Manocan Bridge to Raymonds mill

James Strawbridge appointed Overseer in Manocan hundred from Richard Shunkett into the Main load that Leads from Kings Mills to the head of Manocan —

Merrick Ellis appointed Overseer of the load in Wicatanook hundred from Estens Bridge to the Lower ferry over wicatanook, and white haven town, and from the said ferry to Majr Ballard's Island —

Edmund Dickerson appointed Overseer of the load in Coakamoak hundred from Dividing Creek Bridge to the End of his Uncle's Bounds —

Rowland Beavitt appointed Overseer in Coakamoak hundred to begin where Edmund Dickerson Leaves off and clear his former Limits —

Peter Benton appointed Overseer of the load from Dividing Creek Bridge to Harris' Bridge &c. —

Ambros Niggin appointed Overseer of the load from Harris' Bridge to Thomas Breerton's Plantation &c. —
