Lg. Thomas Dasherell Command was given to the Sheriff of Somerset County that he Should take Robert
 Robert Boyer ^{age 4} Boyer late of Coventry Parish in the County of Glouster if he Should be found in his
 Bailiwick and him Should safe keep so that he might have his Body before the Justices
 of the County Court to be held at Doding Creek in Somerset County after the third Tuesday of August
 Then next to answer unto Thomas Dasherell of glea of trespass upon the Case & and that whereof he Should
 not fail & - and the said Thomas Dasherell by Lewis Gale his attorney declared against the
 Said Robert Boyer in the Glea as follows - In the County of Somerset Robert Boyer late
 of Coventry Parish in the County of Glouster was attainted to answer unto Thomas Dasherell of glea
 of trespass upon the Case & And whereupon the said Thomas by Lewis Gale his attorney Complained
 that whereas the afo Robert the tenth day of May One thousand seven hundred and twenty three at the
 parish afo with in the Jurisdiction of this Court was indebted unto the afo Thomas the sum off five hundred
 and twenty four pounds of tobacco for Sheriffs dues levies & and for bearing thereupon as by aco -
 Recd in Court produced may more fully appear and to hereof being Indebted the said Robert
 in Consideration whereof afterwards viz. the day and year afo at the Glea afo, within the afo -
 Jurisdiction upon himself assumed and to the said Thomas then and there faithfully promised that
 he when afterward he Should be thereto requested the afo sum off five hundred and seventy four
 pounds of tobacco to the said Thomas would well and faithfully Content and pay Neverthe less the
 afo Robert his promise and assumption afo in form afo made Little regarding but plotting and
 fraudulently Intending the afo Thomas in that part to defraud and deceive the afo sum off five hundred
 and seventy four pounds of tobacco to the afo Thomas (alio) the said Robert was thereto
 Requested the tenth day of June One thousand seven hundred and twenty three hale not paid nor
 paid for it in any wise Contented but the said Robert, the same to Thomas further to pay or have
 for it in any wise Content hale altogether refused and still doth refuse whereby the said Thomas
 says he is the worse and hale damage to the value of eleven hundred forty eight pounds of tobacco
 and whereof he brings this Suite Lewis Gale Ques. Eddes & J. Doe Attest -
