And whereas a certain Jo^{seph} Zathbury of Somerset County Clerk became Security for the said Mary Zathbury and acknowledged himselfe Indebted in the Sum of five pound Curr. money to be Levied upon his body goods or Chattell Lands or tenements for the Use of his Said Lordship In Case the Said Mary Zathbury did not appear and answer as aforesaid

At which time the Said Jo^{seph} Zathbury altho. Solemnly called to bring in to Court the Said Mary Zathbury came not but made default &c.

Wherefore it is considered by the Justices that the Right Honorable the Lord proprietary ^{Recover} against the said Jo^{seph} Zathbury by his default the said five pound Curr. money to be Levied upon his Body goods or Chattell Lands or tenements for the Use of the Said Lord proprietary &c.
