Late Sheriff of the said County of agree that they render unto him the full & Just  
Sum of ten thousand Seven hundred and Ninety four pound of good Sound West India  
to bank and Casque which to him they owe & due justly & lawfully &c.

And Where upon the same Thomas of Co. Dashiell his atty. Saith that  
the same Cath. in her Life time on y<sup>e</sup>. twenty Sixth day of May and Dow One thousand  
Seven hundred & twenty two at Somers City and within the Jar. of this Court by her  
:tain Writing obligatory which the said Thomas with the Seale of the said Catharine  
Signed her in Court produced granted her selfe to be Indebted unto y<sup>e</sup>. Thomas in  
the Sum of ten thousand Seven hundred & Ninety four pounds of tobe as and to be  
paid to y<sup>e</sup>. Thomas when afterward she should be better to requested yett y<sup>e</sup>. Cath.  
in her Life time, nor the said Prandell & Anthony West since her decease according  
to the tenor of her said obligation the afd Sum of ten thousand Seven hundred &  
Ninety four pounds of tobe nor any part thereof (after there to requested) unto  
the said Thomas hath not rendered but the same to render hath denyed and still  
doth deny to the Damage of the said Thomas twenty thousand pounds of tobacco  
And there of he brings this Sute &c. - G: Dashiell of Court of Ages Ind. Doe R: Roe

And the afd Prandell West and Anthony West in their proper person Cometh and defend-  
:eth the force and Injury where of and say that they cannot gainray the Sute his action of  
nor can they say but that the writing obligatory afd is the act and deed of the afd Catharine West  
nor but that the debt therein mentioned is yett due and unpaid, where fore the said y<sup>e</sup>.  
Prays Judgm<sup>t</sup>. for his debt afd and his Costs and damages Sustained by Occasion of the  
Doburning of the same debt to him to be adjudged &c.

Therefore it is Considered by the Justice here the fifteenth day of March and  
Dow. One thousand Seven hundred and twenty five that the afd Thomas Dashiell Recover  
against the afd Prandell and Anthony West Executors of the same Catharine West or were  
the Sum of ten thousand Seven hundred and Ninety four pounds of tobacco his debt afd or  
353 also the Sum of three hundred and fifty three - pounds of tobacco for his Costs and  
Damages Sustained by Occasion of the detaining of the same debt to the same Thomas Dashiell  
of his afd by the Court here adjudged, to be Levied of the goods and Chattels of the afd Catharine  
West at the time of her death in hands of Prandell & Anthony West remaining to be administered if so  
much thereof in their hands they have &c. and if so much thereof in their hands they have not &c. than the afd  
afd to be Levied of y<sup>e</sup> pro per goods and Chattels of said Prandell and Anthony West & y<sup>e</sup>. Dof in Mortu<sup>e</sup>
