The Same memorandum the Esq by Jouni Gela his attorney sued out his writs with Ann Renshaw ~~advs~~ of Surifham against the debt the tenor of which writt followeth these words be of the Renshaw ~~advs~~ ~~of~~ ~~Surifham~~ ~~advs~~ Charles absolute Lord & proprietor of the province of Maryland & avolon Lord Baron of Baltimore &c. to the sherr of Somerset County - greeting where as Benj^t Wicks late of Somerset County Gent lately in our County Court of Somerset here to witt, on the sevenleenth day of March last and one thousand seven hundred & eighteen before the worshipfull Charles Ballard and his associates then our Justice of our ^{Saids} Court & by consideration of the same Court recovered against a certain Ann Renshaw of Wreny hundred in the County of Somersett widow ~~advs~~ &c. of J^r Renshaw late of Said County dec^d. as well a certain debt of one thousand one hundred & thirty one pounds of tobe as also the sum of two hundred & fifteen pounds of tobe ~~Costs~~ ~~paid~~ & ~~paid~~ &c. whereof she is ~~convit~~ as by the records & ~~pro~~ ~~of~~ thereof in our Court before our Justice here remaining manifestly appeareth - Nevertheless Execution of the Judgm^t as yett remaineth to be done & because we are willing that those things which in our Courts & rightly done should come to due Execution we command you that by good & Lawfull men of your Bailiwick you make known unto the ~~advs~~ Ann Renshaw that she be & appear before the Justice of our County Court to be hold at Diving feet in Somerset County ~~advs~~ (the)
