Whereupon the said Tobias Pepper Present in Court is at the prayer of the y^e aforesaid attorney adjudged to give Special Bail to the return aforesaid Thereupon a certain William Marchmont of Somersett County Clerk present here in Court undertakes for the said Tobias Pepper that if in case the said ~~Joseph~~ Joseph M^r Carter shall recover Judgment in the plea aforesaid against the aforesaid Tobias Pepper or that the said Tobias Pepper shall be therein Convict that then the said Tobias Pepper shall pay the Condemnation of the Court thereupon unto the said Joseph M^r Carter or tender his Body to the Custody of the Sher^{iff} of Somersett County in Satisfaction thereof & that he the said William Marchmont will do it for him

And thereupon the said Tobias Pepper in his own proper person found and defendeth the force and Injury whereof and says that he cannot gain say the aforesaid Tobias's actions aforesaid as aforesaid against him brought nor can he say but that the said Tobias ought to recover his Damages by Quantum of the premises aforesaid to Six hundred and Ninety Six pounds of t^o and Costs of Suite against him which the said Tobias doth not gain say

Therefore it is considered by the Justice here the fifteenth day of March and Found One thousand Seven hundred and twenty five that the aforesaid Joseph M^r Carter Recover ag^t the aforesaid Tobias Pepper as well the Sum of Six hundred and Ninety Six pounds of t^o his Damages aforesaid in form aforesaid as also the Sum of Two hundred and Sixty Six pounds of t^o by the Court here adjudged unto him for his Costs and Charges by him about his Suite in this behalf Said Out and Expended and the aforesaid Debt in Money
