

and twenty four at the County ass within the Jurisdiction of this Court was Indebted unto the ass Robert the Sum of five barrels of good sound Indian Corn, and five hundred pounds of tobacco as by a note herewith in Court produced may appear, and for thereof being Indebted the Same Daniel in Consideration thereof afterwards to wit the day and year afo, at the County ass within the Jurisdiction afo, upon himself assumed and to the Same Robert then and there faithfully promised that he when afterwards when he should be thereto requested he would well & faithfully Content and pay, Nevertheless the afo Daniel his promise & assumption afo in form afo made Little regarding and plotting and fraudulently Intending the afo Robert in that part to be defrauded and deceive the afo Sum of five barrels of good sound Indian Corn, and five hundred pounds of tobacco, or any part thereof to the Same Robert hath not paid or him for it in any wise Contented altho. afo Requested afterwards to wit the tenth day of November Seventeen hundred & twenty four at the County ass, within the Jurisdiction afo, but the Same hitherto, to the Same Robert to pay hath altogether refused and shew'd oth. refuse whereby the Same Robert Says he is the worse and hath damage to the value of One thousand pounds of tobacco & ten barrels of Corn and thereof he brings this Suite p^r. *Joani hale of Quer Sedgwick de Don Koe*

And the afo Daniel Burqui in his Own proper person comes and defends the same p^r injury when he and Saith that he cannot gain say the p^r his action afo so as afo against him brought, nor can he say but that the Said p^r ought to Recover his Damages by Occasion of the premises afo to five Barrels of Indian Corn and five hundred pounds of tobacco, and Costs of Suite against him which the Said p^r doth not gain say p^r.

Therefore it is considered by the Court here the Sixteenth day of March and Sent. One thousand Seven hundred & twenty four that the afo Robert Maycomb Recover against the afo Daniel Burqui as was the Sum of five barrels of good Indian Corn & five hundred pounds of tobacco his Damages by Occasion of the premises afo and in form afo Confirmed as also the Sum of ⁽²²⁵⁾ Two hundred & Twenty five - - - pounds of tobacco by the Court here adjudged unto him for his Costs and Charges by him about his Suite in this Behalf Said Out and Expended by the afo Danice Burqui in Money p^r.
