

whereupon the afd Gabriel Daley in his own proper person appears and thereupon the said Gabriel Daley at the Prayer of the afd attorney afd is ad judged to give Special Bail to the afd but for want hereof the said Gabriel Daley is committed into the custody of the Sheriff of Somerset County there to remain &c. the said Sheriff to wit, ^{Francis Allen Gent} Brent here in Court took charge of the said Gabriel Daley accordingly; afterwards in the same Court came a certain Richard Blunkett of Somerset County Esq. and undertakes for the said Gabriel Daley that if in case the said Joseph M^r Carter shall recover Judgment in the Plea afd against the said Gabriel Daley or that the said Gabriel Daley shall be therein convicted that then he the said Gabriel Daley shall pay the condemnation of the Court, or render his body to the custody of the Sheriff of Somerset County in such fashion hereof or that he the said Richard Blunkett will do it for him & thereupon the said Gabriel Daley is discharged from out of custody of the Sheriff of Somerset County for if cause afd

Whereupon the said Gabriel Daley in his own proper person comes and defendeth the force and injury when &c. and says that he cannot gainsay the afd his action afd so as afd against him brought nor can he say but that the said Joseph ought to recover his damages by reason of the non performance of the promise and assumption afd to seven hundred and twenty eight pounds of t^o and four of s^t against him which he said afd doth not gainsay.

Therefore it is considered by the Justices here the twenty first day of June and Dow One thousand Seven hundred and twenty six that the afd Joseph M^r Carter recover against the afd Gabriel Daley as well the sum of seven hundred and twenty eight pounds of t^o his damage afd in form afd confessed as also the sum of three hundred & twenty pounds of t^o by the Court here ad judged unto him for his costs and charges by him about his Suite in this behalf said out and expended and w^o afd Dofh in Mercy &c.
