

Allen Shall Recover Judgment in the Plea aforesaid against the said Thomas Goddard or that the said Thomas Goddard shall be therein convicted that then he the said Thomas Goddard shall pay the condemnation of the Court thereupon or Render his body to the custody of the Sheriff of Somerset County in Satisfaction hereof that they the said John Ledwell and Alexander Adams will do it for him &c

Whereupon the said Thomas Goddard in his own proper person comes and defends the force of Injury where aforesaid and says that he cannot gain say the Eschewation aforesaid against him brought nor can he say but that the Writing Obligatory aforesaid is his act and deed and that the debt therein mentioned is yet due and unsatisfied wherefore the said Eschew prays Judgment for his debt aforesaid and his costs and Damages sustained by reason of the detaining of the same debt &c

Therefore it is considered by the Justices here the twenty first day of June aforesaid. One thousand Seven hundred and twenty Six that the said Francis Allen Recover against the said Thomas Goddard his debt aforesaid to Eight thousand pounds of 1000 as also the Sum of 8000 pounds of 1000 for his costs and Damages sustained by reason of the detaining of the same debt to the same Francis of his aforesaid by the Court here aforesaid judged with Stay of Execution until the tenth day of November Next and the said Dofh in Mercy &c
