As To the Sheriff of Somerset County greeting where as a certain Levi Denwood ad. Dilect. Seaven
Denwood lately in Our County Court here to witt the fifteenth day of June and died One thousand Seven
hundred and twenty five before Samuel Hogkins Gent and his associates then Our Justices of Our County
Court of Somerset at Dwiding Creek and by consideration of the same Court Recovered against a certain
Michael Holland late of Somerset County Esquire ad. Dilect. Michael Holland of this County of Somerset
in the Province of Maryland as well a certain Debt of One hundred and Sixty pounds Curr. money of
Maryland as also the sum of four hundred and Nine pounds of Tobacco which to the same Levi Denwood
same Court were adjudged for his costs and damages which he had by Obstruction of the execution of the
Debt of whereof he is Committed as by the Record and proofs thereof in Our Court before Our Justices at
Dwiding Creek now Remaining manifestly appeareth Nevertheless Execution of the Judgment of the Court as yet
Remaineth to be done and the said Levi Denwood is since dead as by the Intimation of Betty Gale &
Levi Gale Executors of the Testament of the said Levi Denwood we have Received and because
we are Wishing that those things which in Our said County Court are Rightly Done should come to
due Execution; we Command you that by good and Lawfull men of your Body with you make known
unto the said Michael Holland that he be and appear before the Justices of Our County Court to be held at
Dwiding Creek the third Tuesday of March next to shew Cause if any thing for himselfe he hath or knoweth
to say wherefore the said Betty Gale and Levi Gale ~~and Betty Gale~~ Executors as aforesaid, their Executors
against the said Michael Holland of the debt and damages aforesaid ought not to have according to the
form of the Recovery aforesaid if to him it seemeth Expedient and have you then & there the Names of those

At which said third Tuesday of March to witt the fifteenth day of the same month and died One
thousand Seven hundred and twenty five being the day of the Return of the said Writ Cometh the said
Betty Gale and Levi Gale; and Sheweth the Sheriff of Somerset County to whom the foregoing Writ
