At which said Next Court to wit the twentyfirst Day of June and Dowd One thousand Seven hundred and twenty Six Came againe as well the said Joshua George by his attorney and as the said Nehemiah Nicholson by his attorney and thereupon the said Nehemiah by his said attorney Says that he cannot gain say the Plaintiff his action and so as a against him brought nor can he say but that the said Plaintiff Ought to Recover his Damages by Quareon of the Non performance of the promise
