that whereas he aforesaid Nethemiah the last day of June being Dowd one thousand Seven hundred and twenty six and within the County of Somerset within the Jurisdiction of this Court was indebted to the aforesaid Joshua in sum of two pistoles of the value of two pounds Seven shillings & ten pence curr. money for divers services by the same Joshua for the same Nethemiah at his private instance and request before it time done so thereof being indebted the said Nethemiah in Consideration whereof afterwards to wit the same day and year aforesaid at the County aforesaid within the said Jurisdiction upon himself affinced to the same Joshua then and there faithfully did promise that he afterwars he shoulde be thereto requested he the aforesaid sum of two pistoles to the said Joshua wad well and faithfully content & pay never the less the said Nethemiah the aforesaid sum of two pistoles or any part thereof to the same Joshua (alio afterwards to wit the same day & year aforesaid at the County aforesaid within the said Jurisdiction was thereto requested)

but not paid or the same Joshua for it as aforesaid but the same Nethemiah the same further to doe hath altogether refused and still doth refuse to the damage of the same Joshua of five pounds curr. money and whereof he bringeth this Suite &

At which said Next Court to wit the twentyfirst day of June and Dowd One thousand Seven hundred and twenty six againe as well the aforesaid Joshua George by his attorney aforesaid the said Nethemiah Nicholson by his attorney aforesaid and hereupon the said Nethemiah by his said attorney says that he cannot gainsay the Eliz his action aforesaid so aforesaid against him brought nor can he say but that the aforesaid Eliz ought to Recover his damages by Queson of the Non performance of the promise aforesaid
