and Execute the same Commission according to Law in such Case made and provided &c

Whereupon it is Ordered by the Court that the Shew. of Somerset County Return
a sufficient Number of good and Lawfull men of his Bailiwick to Complot and make up a grand
Jury for the County of Somerset &c. Thereupon the said Shew. being called makes Return of
the Names of the grand Jurors Return the same which Jurors are as followeth viz. James M^r. Meric
Isaiah Bradate, Martin Kennett, Benjamin Tull, Jonathan Coughton, Edmund Capper, John Townsend J. d.
Alexander Saakey, Lewis Disharoon, Abraham Smith, Richard Knight, Giddion Silman, Thomas Gray,
Robert Mitchell, Robert Harris, John Broughton and Daniel Caudery who being severally called
appeared and were charged and sent out to consider who soon after Return and present to the Court here one
