Came the said William Roberts and being by the Sher. Set to the Bar is thereupon Instantly demanded how he would acquitt himselfe of the premises afo^r. Says that of the premises afo^r he is in no way quilly thereof, and thereof for by aye putteth himselfe upon the Country and Lewis Gale who for his said Lordship in this Baludfe Prosecutes Likewise —
