And the aff^s Mary Eson admits as aff^s by George Dashole her attorney Cometh and defends the fore and Injury when Geo. and Gray's Leave to Impart hereunto until the Next Court and she hath it and the same day is given to the aff^s Blantife also -

At which said Next Court to witt the Sixteenth day of August and Dand One thousand Seven hundred and Twenty Six came again as well the aff^s Joseph M^r Clerk as the aff^s Mary Eson by their attorney's aff^s and whereupon the said Mary by her said attorney says that she cannot gain say but that the aff^s Benjamin Eson in his life time did promise and upon himself a sum in manner and form as the aff^s Joseph by declaring aff^s above supposed, nor can she say but that the aff^s Joseph ought to recover his damages by reason of the Non performance of the promise and assumption aff^s to four thousand Eight hundred and thirty Eight pounds of Tobo. and cost of Suite which the said aff^s doth not gain say &
