Whereupon the said William Robinson in his own proper person appears and thereupon the said William Robinson at the prayer of the p^lt^s attorney is adjudged to give special bail to the action of Thereupon a certain John Dennis Sen^r. present here in Court undertakes for the said William Robinson that if in case the said Thomas Dashed shall recover Judgment in the plea of against the said William Robinson or that the said William Robinson shall be therein Convict that then he the said William Robinson shall pay the Condemnation of the Court thereupon or tender his body to the custody of the Sher^t. of Somerset County in Satisfaction thereof or that he the said John Dennis will do it for him &c

Whereupon the said William Robinson in his proper person cometh and defendeth the force and Injury when &c. and says that he cannot gain say the action of, nor can he say but that he did upon himself assume ~~an apprehension~~ in manner and form as the said Thomas against him hath declared, nor can he say but that the said Thomas ought to recover his damages by reason of the premises and to the sum of Seven hundred and fifty Seven pounds of 10^s and 6^d of Sute against him which the said p^lt^s doth not gain say &c.
