By the Justices here the Sixteenth day of August One thousand Seven hundred and twenty six that the afo^d Thomas Dashiell recover against the afo^d William Robinson the sum of Seven hundred and fifty seven pounds of tobacco damages afo^d in form afo^d Conferred as also the sum of three hundred and ten pounds of tobacco for his costs and charges by him about his Suite in that part Regarded to the same Thomas by the court hereof his afo^d adjudged &c and the afo^d day in Mercy &c

Daniel Sharradon summoned to answer unto Mary Martin Esq^r of the West wile & testament of Robt Martin decd of agree that he render unto her one thousand four hundred & four pounds of tobacco which he unjustly detaine^d

And whereupon the same Mary by Recd of her atty Copley & alrea^d the afo^d Daniel the twenty eighth day of July Anno Domini one thousand Seven hundred & twenty four at Somersett County afo^d within the Jurisdiction of this Court by his certain writing obligatory whiche the same Mary signed with the Seal of the same Daniel herein to Court brought in record himself to be held & firmly bound unto d^r afo^d Robt in his life time and sum of one thousand four hundred and four pounds of tobacco to be paid the same Robt his executors or assignees when afterward the afo^d Daniel should be there to required yet d^r Daniel tho^r often thereto required the afo^d sum of one thousand four hundred & four pounds of tobacco to the afo^d Robert in his life time nor the afo^d Mary since his death hath not rendered but a sum of the same Daniel the same hitherto to do hath altogether Denied and still doth deny to the damage of the same Mary three thousand pounds of tobacco whereof she bringeth her suit & - and the same Mary brings hereinto Court the letters testamenteary & by whiche &

And whereupon the afo^d Daniel Sharradon in his proper person cometh & defon-
deth the force & injury wherof and saith that he cannot gain say the actions afo^d
of the afo^d Mary Martin Esq^r as afo^d nor but that he sustained from the afo^d Mary the afo^d sum
and four hundred & four pounds of tobacco in manner & form as the same Mary above afo^d
him complained - Therefore it is considered by the Justice here the Sixteenth
day of August Anno Domini one thousand Seven hundred & twenty six that d^r afo^d Mary Martin
Esq^r of the same Robert Martin recover against the afo^d Daniel Sharradon as well the sum
of one thousand four hundred & four pounds of tobacco her debt afo^d as also d^r sum of
212 Two hundred & twelve - - pounds of tobacco for her Damages which she sustained
as well by reason of the detaining of d^r same Debt as for her Costs & Charges by
her about her Suite in that part Expended to the same Mary by the court here
of her afo^d adjudged & and the afo^d day in Mercy &c
