

unto ^{the} Thomas Deal one of the party's deprived four fold of the value of the Boat and amounting in the whole to ^{two} hundred pounds of tob^o, also that he pay unto the ^{and} Francis Allen another of the party's deprived four fold of the value of the goods mentioned & said from him to be stolen, amounting in the whole to four hundred and forty pounds of tob^o, as also that he pay unto the said John Gowen, another of the party's deprived, four fold of the value of the goods mentioned in the Indictm^t from him to be stolen, amounting in the whole to two hundred and Ninety six pounds of tobac^o - Likewise that he pay unto the said Calahak Whitmore, the other of the party's Deprived four fold of the value of the goods mentioned in the Indictm^t, from him to be stolen amounting in the whole to three hundred and forty four pounds of tob^o. (the ^{and} Boat goods and Stuffs being by the Court valued according to Law as ^{and}) and that the ^{and} John Bidell be whipt with five Lashes on the bare back well said on until the blood appear, and that he stand in the pillory a quarter of an hour, and that he be taken ^{and} thereupon as to the Corporall punishment ^{and} Command is given to the Sher^{iff} of Somerset County that he do thereof Immediate Execution according to the Indictm^t ^{and} rendered, by whiping the ^{and} John Bidell at the Publike whipping Post with five Lashes on the bare back well said on until the blood appear, and by sitting him in the pillory a quarter of an hour ^{and} afterwards in the same Court the Sher^{iff} returns that he has done the Execution of the Indictm^t ^{and} as to the Corporall punishment ^{and} he was commanded, whereupon the said John Bidell is ordered by the Court to give Security for the paymt of the four fold ^{and} Officers fees, due to the ~~Law~~ ^{Officers} by reason of the premises ^{and}, but for want thereof the said John Bidell is committed ~~committed~~ into the custody of the Sher^{iff} of Somerset County there to remain the said Sher^{iff} being present took charge of the said John Bidell accordingly ^{and}

Wherefore it is considered by the Justice here that the ^{and} W^m. Allen ^{and} Edward Coleman pay unto the ^{and} Thomas Deal one of the party's deprived four fold of the value of the Boat ^{and} amounting in the whole to two hundred pounds of tob^o also that he pay unto the ^{and} Francis Allen another of the party's deprived four fold of the value of the goods mentioned & said from him to be stolen, amounting in the whole to four hundred & forty pounds of tob^o. as also that he pay unto the said John Gowen, another of the party's deprived, four fold of the value of the goods mentioned in the Indictm^t. from him to be stolen, amounting in the whole to two hundred & Ninety six pounds of tob^o. Likewise that he pay unto the said Calahak Whitmore the other of the party's Deprived four fold of the value of the goods
