

then Judicially sitting and acknowledged themselves indebted to his said Lordship the right Honble the Lord Proprietary of this Province that is to say the said Anthony West in the sum of one hundred pounds Sterling and the said Andrew Thompson & Randal West severally in the sum of fifty pounds Sterling good & Lawfull money of England of their goods & Chattells Lands & Tenements severally to be made & Seized to the Use of his said Lordship the Lord Proprietary his heirs & Successors - In Case the said Anthony West shall ^{not} make his personall appearance before the Justices of his Lordships County Court of Somerset to be held at Dividing Beck the third Tuesday of March then next to answer unto his said Lordship concerning his feloniously Stealing forty pounds Currant money being the proper money of the said John Williams whereof the said Anthony West stands Indebted and to stand & abide the Judgment of the Court thereon and not to depart the same Court without License thereof otherwise to be void & -

John Williams, William West, and William Croser of Somerset County Planters being bound by Recognizance for their appearance this Court to give Evidence on behalfe of his said Lordship against a certain Thomas Bannister and Anthony West concerning their feloniously Stealing forty pounds Currant money being the proper money of him the said John Williams & appeared herein Court according to the tenor of their said Recognizance and pray that their appearance may be recorded and they discharged from the same Recognizance, thereupon the appearance of the said John Williams, William West and William Croser were recorded and they accordingly discharged - Whereupon it is further ordered by the Court that the said John Williams, William Croser, and William West, William Clauner John Tilmann, William Furnis, ^{and} Abell Wright Jun^r of the County are ordered to give Recognizance in the sum of eighty pounds Sterling ^{each} for their appearance at March Court next to be hold for the County at Dividing Beck the third Tuesday of the same month (and that the said William West give Security for his appearance) to give Evidence against the said Thomas Bannister and Anthony West as aforesaid - Whereupon the said John Williams, William Croser, William Clauner John Tilmann and William Furnis and Abell Wright Jun^r all present in Court in their proper persons acknowledged themselves to owe and be indebted unto his said Lordship the Lord Proprietary severally in eighty pounds Sterling good and Lawfull money of England, of their goods and Chattells Lands and Tenements severally to be made and Seized to the Use of his said Lordship -

In Case they do not make their personall appearance before the Justices of his said Lordships County Court of Somerset to be held at Dividing Beck the third Tuesday of March then next to give Evidence as they shall know against the said Thomas Bannister and Anthony West of and concerning their feloniously Stealing of forty pounds Currant money being the proper money of the said John Williams, and not to depart thence without the leave of that Court, otherwise to be void & -

Likewise the said William West, with Randal West his Security both present in Court acknowledged themselves to owe and be indebted unto his said Lordship the Lord Proprietary, severally in eighty pounds Sterling good and Lawfull money of England of their goods and Chattells Lands & Tenements severally to be Seized and made for the Use of his said Lordship the Lord Proprietary this
