And whereupon the said Giles Barkaw present here in Court and being by the Sher^{iff} set to the bar. is thereupon at the prayer of the afo^r attorney committed into the custody of the Sher^{iff} of Somerset County unto the afo^r Andrew Scott of his damages and Cost as above should be thereof fully satisfied - the said Sher^{iff} present here in Court took Charge of the said Giles Barkaw accordingly &c
