according to your Laws Orders & Customs of that part of your Kingdom of Great Britain
Called England as of this our province of Maryland in which said Actions are to be
tryed we do constitute Ordain & appoint you y^r Sam^t Hopkins, W^m Clamer,
J^o Jones, W^m Faust, J^o Smith, W^m Stoughton, J^o Caldwell, J^o M^cClester.
J^o Haudy James Dashiel, J^o Scott & Rob^t King and none other to be Judge
also by these presents we do Command y^r Sheriff of our Said County of Anne
of holding severall Courts to be held for our Said County he give his attendance
and cause to come before you or any three or more of you as also such & many
goods lawfull men of his Bailewick out of each & every hundred thereof
by whom y^r truth of y^r Matter in y^r premises may be y^r better known and
Enquired of lastly you shall cause to be brought before you at your Said
Courts all Writs Precepts process & Judgements to your Courts and
Jurisdiction belonging of the same may be Inspected & by Due Course of Law
