Which being Read and heard, Whereupon William Clanner, John Jones, W^m Paritt
 John Smith W^m Stoughton John Caldwell and John M^cKeister Gent. Pursuant to the dedimus
 to them directed administered the severall Oaths appointed by act of assembly to be taken
 to the government and the accustomed Oath of Justice to Samuel Hopkins and John Scott
 who severally take the same and subscribe the Oath of abjuration and test and take
 their places - Thereupon Samuel Hopkins and John Scott Gent. administered the
 same Oath to W^m Clanner John Jones, W^m Paritt John Smith W^m Stoughton, John Caldwell
 and John M^cKeister who take the same and severally subscribe the Oath of abjuration &
 Test and take their places as followeth viz

 And thereupon Proclamation being made by the S^r according to Custom form

The Jurors afo^r so as afo^rsd Impanelled being severally called over by their Names do appear
 as above and thereupon they are sworn and charged and sent out to consider ^{who} soon after the
 grand Jurors afo^r Return into Court and being severally called over appear and present to the
 same Court here the following present viz Present against Rosannah Roanough, Rebecca
 Humming, Eliz^a Miller, and Mary Stevens, being content that the Court should amend form -
 altering no manner of substance in them, thereupon the afo^rsd Grand Jurors were accordingly
 discharged and ordered that they ^{should} be allowed for their Publick Service this Court four hundred y^d
 of to be paid next Levy Court, and against the afo^rsd Rosannah Roanough, Rebecca Humming
 Eliz^a Miller, and Mary Stevens, so as afo^rsd Breached it is ordered of the S^r if they Return able
 to Next Court &
