

To witt the fifteenth day of June anno: Doct: One thousand Seven hundred twenty five Comes the said  
 Comfort Newman in Custody of the Sherif: aff into whose Custody before that time was committed for the same  
 aff, and the said Comfort Newman being by the Sherif Sett to the Barn is. Whereupon Justly demanded how  
 She would acquit herself of the present felony aff. Saith that of the felony aff she is not ways guilty  
 thereof, and there aff by her selfe putt herself upon the Country, and Lewis Hale who for his said Lordship  
 in his behalfe prosecutes Likewise - Thereupon command is given to the Sherif: of Somerset  
 County that immediately he cause to come here twelve & who neither & to require & because as many  
 of which said Except the said Sherif: to witt Joseph McClester Gent: makes return that he hath here  
 Ready twelve & as by his said precept he was commanded, and the Jurors of that Jury wherein -  
 Impounded being called came to witt Merrick Eller, John Dennis Senr: John Fleming, Robert Middle  
 Adam Hulme, Thomas Leale, Robert Oliver, John Townsend Senr: John Tuck, William Bruton, Joseph  
 Houlston and Thomas Collins, who being duly called tryed & Sworn to say the truth in the premises,  
 upon their Oath do say that the said Comfort Newman is guilty of the felony whereof she stands -  
 Indicted & whereas the said Comfort Newman being found guilty of the felony aff. by the  
 Evidence of the party deprived of the goods aff. therefore by Law now four fold is due her -

Wherefore it is considered by the Court that the said Comfort Newman be whipt with  
 fifteen lashes on the bare back well laid on untill the blood appear, and that stand in the pillory  
 a quarter of an hour & that she be taken & carried thereupon as to the corporate punishment  
 aff command is given to the Sherif: of Somerset County that he doe there of Immediate Execution  
 according to the Judgment aff Rendered by whipping the aff Comfort Newman at the Publick whipping  
 post with fifteen lashes on the bare back well laid on untill the blood appear, and by setting  
 her in the pillory a quarter of an hour, and afterwards in the same Court the Sherif: Returns that  
 he hath done His Execution of the Judgment aff as to the corporate punishment aff he was commanded  
 Whereupon the said Comfort Newman is Ordered by the Court to give Security for paym't of  
 all the Officers fees due by means of the premises aff - but for want thereof the said Court  
 Newman is committed into the custody of the Sherif: of Somerset County More to be done by the said Sherif:  
 present herein Court took charge of the said Comfort Newman accordingly &
