The same Command was given to the Sher of Somerset County that he should take Abraham Mason late of Somerset County Blunter if he should be found in his Bayly: and him should safe keep so that he might have his body before the Justice of his Lordships County Court of Somerset to be held at Dividing Creek the third Tuesday of March then next to answer unto Jos: M^r M^raster of a plea of Tres pass upon the Case &c. and that thereof he should not fail &c. and the aff Joseph M^r M^raster by Lewis Gale his atty proceeded against y^e Abraham Mason in the plea aff as followeth viz^t

Abraham Mason late of Somerset County Blunter was attached to answer unto Jos: M^r M^raster of a plea of Tres pass upon the Case &c. And where upon y^e Jos: by Lewis Gale his atty Complaines y^t where as the said Abraham y^e first day of Novemb^r Anno Dom: one thousand Seven hundred & twenty six at Somerset County aff within y^e Jur^t of this Court was indebted unto y^e Jos: in two thousand two hundred & twenty one p^{ts} of Tobo: as by aut^r here unto annexed may apper & being so there of indebted the said Abraham in consideration thereof the day & year aff at y^e place aff upon himselfe did assume & to the said Jos: then & there did faithfully promise y^t he y^e said Abraham y^e said two thousand two hundred & twenty one p^{ts} of Tobo: to y^e said Joseph when he should be there unto requested he would well and faithfully pay & Content & altho: y^e said Abraham six hundred & eleven pounds of Tobo: full of the said debt to y^e said Joseph he hath paid & satisfied yett as to y^e residue thereof being one thousand six hundred & ten p^{ts} of Tobo: y^e said Abraham his promise & assumption aff in forme aff made Nothing regarding but plotting & fraudulently Intending y^e said Jos: in y^e part Craftily & Subtily to Deceive and Defraud y^e said Jos: one thousand six hundred & ten p^{ts} of Tobo: low^d Jos: hath not paid altho: the same to doe hath refused & still doth refuse & deny to the dam^t of y^e said Jos: of three thousand two hundred & twenty p^{ts} of Tobo: & there upon he bring Suite &c.
