w^t Comette maketh return hereof to the Court here endorsed in these
words following vizt — Ex parte dict^r delivered in the name of Fran^r Allen Sher^r

And the said Abraham Mason being present here in Court is at y^r of prayer of
R^r atty afo adjudged to give Speciall Bail to satisfaction and thereupon a certain
Hd^r Newbold late of Somersett County Blanter present here in Court undertakes
for the afo said Abraham Mason if in case w^t afo Joseph M^rester shall recover
Judgement the glea afo against the afo Abraham Mason or y^r they^r said Abraham
Mason shall be there in Court that then he w^t afo Abraham Mason shall
pay the Indemnition of the Court thereupon or under his body to the Costes
of the Sher^r of Somersett County in Satisfaction whereof the afo Hd^r Newbold
will do it for him &c

Whereupon the afo Abraham Mason in his own proper Person comes & defends
the force & injury whereto & saith he cannot gainsay satisfaction affor-
but y^r he did afforse upon himself & in manner & forme as the afo J^r M^rester
above against them hath complained nor can he say but that w^t afo J^r M^rester
hath sustained Dam^r by occasion of the non performance of his promise
affumption aff too one thousand six hundred and ten £^r of L^r & the same
Declaration in all the words before expressly confesseth

Therefore it is considered w^t afo J^r M^rester recover against the afo
Abraham Mason as well the sum of one thousand six hundred & ten £^r of L^r
his Damages aff by him in his Declaration above supposed as also sum of
three hundred & twenty seven £^r for his Costs & Charges by him
about his suit in part regaded to the same J^r M^rester by Court hereof his
assent adjudged the afo D^r in Mer^r &c
