Witneſſe of foregoing Writ was directed ſimelie Māketh return thereof  
to the Court here endorſed in these words following vizt — *Cypriogus dicitur delivere*  
*in tunc f. Francis Allen Sher* —

And of said Raudell West being present here in Court is at y<sup>e</sup> prayer of the C<sup>t</sup> attly ad adjudged to give ſpeciall Bill to y<sup>e</sup> action aſt here upon a certaine Wm West  
e Anthony West both of Somett County Planter present here in Court undertake  
for of said Raudell West if in Case of aſt Drs: M<sup>r</sup> Chester Shall recover Judg<sup>m</sup>t  
in y<sup>e</sup> pleas aſt against the aſt Raudell West or if Said Raudell West ſhall be  
herein Convict of then he the ſaid Raudell West Shall pay the Condemnation of the  
Court here upon or under his Body to y<sup>e</sup> C<sup>t</sup> of y<sup>e</sup> Sher of Somett County in  
ſatisfaction hereof or they of ſaid Wm West & Anthony West will do it for  
him aſt —

And the aſt Raudell West by George Darke his attorney comes and defend  
the ſame and injury when w<sup>t</sup> & And the ſame attorney, ſay that he is not informed by the ſame  
Raudell West his Agent of any anſwer of the ſame deſh to the aſt C<sup>t</sup> in the pleas aſt to be  
given and nothing else therof ſays by which the ſame p<sup>t</sup> R<sup>t</sup> amag against the aſt deſh  
here of undenied — wherefore the aſt Joseph Pur damage by Occasion of the Non perfor-  
mance of the Promife and aſumption aſt against the aſt Raudell Right to recover —

Whereupon at the Prayer of the aſt Joseph and by the Consent of the aſt Raudell  
the Justices here according to Act of Assembly in ſuch Case made and provided doth award the  
damage of ſome p<sup>t</sup> by Occasion of the non performance of the promife and aſumption  
aſt besides his Cork and Chorges by him about his ſuite in that Part Expended to him two  
ſand and Hury One pound of tobacco —

Therefore it is Considered that the aſt Joseph M<sup>r</sup> Chester Recover againſt the aſt  
Raudell West two thousand and Hury One pound of tobacco his damage aſt by the Justices  
458 and inform aſt aſped as also from hundred and fifty eight — pounds of  
tobacco for his Cork and Chorges by him about his ſuite in that Part Expended to the ſame  
Joseph by the Court here of his aſent adjudged and the aſt deſh in mercy w<sup>t</sup> —

Lg. The ſame — *Contraſt* was given to the Sher of Somett County that he ſhould  
take Anthony West late of Somett County Planter if he ſhould be found  
q<sup>d</sup>. Anthony West in his Bailewick he muſt ſafely keep so y<sup>e</sup> the night have his Bod,  
before the Justices of his Lordships County Court of Somett to be tried

frefga upon y<sup>e</sup> ſe<sup>t</sup> — And whereupon y<sup>e</sup> ſame Drs: M<sup>r</sup> Levin Gale his attly  
Complaines y<sup>e</sup> where as aſt Anthony, w<sup>t</sup> tenth day of November anno domini one thouſand
