And the said Anthony West by George Dashiell his attly Comer & Defends the force and Injury when due and the same attly says if he is not Informed by the same Anthony West by way of any answer for the same Debt to the said Blf in the plea and to be given nothing else thereof says - by which if same Blf remains against the said Debt thereof undesfended - wherefore if the said Defor: his Damages by occasion of the Non performance of the promise & assumption and against the said Anthony West ought to recover -

Whereupon at the prayer of the said Defor: M^r Cester & by the Consent of the said Anthony the Justices here according to act of asemble in such case made & provided did award the Damages of same Blf by occasion of the Non performance of the promise & assumption and besides his Costs & Charges by him about his suite in y^e part expended to Twelve hundred & Eighty Eight p^{ts} of p^{b}

Therefore it is Considered if the said Defor: M^r Cester Recover against the said Anthony West Twelve hundred & Eighty Eight p^{ts} of p^{b} his Damages and by the Justices and in forme and as aforesaid as also the Sum of three hundred & thirty pounds of p^{b} for his Costs & Charges by him - about his suite in y^e part expended to y^e same Defor: by the Court here of his assent adjudged & the said Debt in Mercy &c
