And the said Solomon Full being present here in Court is at y<sup>e</sup> prayer of the afo<sup>r</sup> atty afo<sup>r</sup> adjudged to give special Bail to y<sup>e</sup> action afo<sup>r</sup> thereupon a certain Lazarus Maddox late of Southwell County Claute Present here in Court undertakes for y<sup>e</sup> Said Solomon Full y<sup>e</sup> if in case y<sup>e</sup> afo<sup>r</sup> Jos: McCester shall recover y<sup>e</sup> Judgment in the plea afo<sup>r</sup> against the afo<sup>r</sup> Solomon Full or y<sup>e</sup> Said Solomon Full shall be therein convicted y<sup>e</sup> then he the said Solomon Full shall pay the condemnation of the Court thereupon or render his Body to the custody of the Sher of Southwell County in Satisfaction thereof or y<sup>e</sup> Said Lazarus Maddox will do it for him &c
