Somerset County Planter present herein Court undertakes for the said Cheever Hall
y^t if in Case the afd Jos. M. Cester shall Recover Judgment in y^e plea afd against y^e afd Cheever
Hall or y^e said Cheever Hall shall be therein Convict y^t then he y^e said Cheever Hall
shall pay the Condemnation of the Court thereupon or under his Body to the Custody
of the Sher. of Somerset County in the Satisfaction thereof or y^t he y^e said Wm. Hall will
do it for him &c

Whereupon the afd Cheever Hall in his own proper Person comes & defends y^t
Force & Injury when the afd afd of the Court cannot gain say the action afd nor but y^t the
afd afd upon himselfe in manner & forme as y^e afd Jos. M. Cester above against
