and within the Jur^r of this Court by his certain writing obligator^y which of same
Jno^t with his Seal of w^t Rob^t sealed here into Court Beings whose date is w^t same day
year acknowledged himselfe held & firmly bound to the said Jno^t in w^t Rob^t thirt^y
£ curr^t Silver money of America to be paid unto w^t Rob^t when afterwards he
should be there unto required yett w^t Rob^t all the often there unto required
w^t Rob^t thirt^y £ curr^t money to w^t Rob^t hath not paid but of same to him hitherto to
pay hath denied & still doth deny whereupon of same Jno^t saith of he is deter-
mined & hath dw^r to the value of forty £ like money & thereof brings suite &
