A Copy of the foregoing declaration was made and sent with the Writ in the plea aforesaid — At which said third Tuesday of June ~~of 1725~~ to wit the fifteenth day of the same month and Dowd One thousand Seven hundred and twenty five being the day of the return of the said Writ Cometh the said William Pepper by his attorney aforesaid and the Sherif of Somerset County to whom the foregoing Writ was directed *vs* *the Cldg.* and made the return thereof endorsed in these words *vs* *Doct* *vs* *Hoe*

And the aforesaid Tobias Pepper in his own proper person Cometh and defends the fore and Injury aforesaid and says that he cannot gainsay the aforesaid his action aforesaid against him brought nor can he say but that the writing Obligatory aforesaid is his act and deed and that the debt therein mentioned is yett due & unsatisfied wherefore the said aforesaid *vs* *Doct* *vs* *Hoe* for his debt aforesaid and his costs and damages sustained by Omission of the detaining the same debt &c. Therefore it is considered by the Court that here the fifteenth day of June and Dowd One thousand Seven hundred & twenty five that the aforesaid William Pepper Recover against the aforesaid Tobias Pepper as well the Sum of five thousand pounds of Tobacco his debt aforesaid as also the Sum of three hundred and seventy *vs* *Doct* *vs* *Hoe* pounds of Tobacco for his costs and damages sustained by Omission of the detaining the same debt to the said William Pepper of his aforesaid by the Court here ad judged & the aforesaid Tobias in Money &c.

And whereupon the said William by Francis Allen his attorney Saith that Whereas the said Bowman the
twenty first day of Novemb. and Dowd One thousand Seven hundred and twenty One of Somerset County within
the Jurisdiction of this Court by his certain bare Obligatory which the said William with the Seal of the said
Bowman Signed here unto Court brings the date whereof is the same day and year did acknowledge
himself to be bound unto the said William in the aforesaid Eight Pound Nine Shilling to be paid unto the
said William upon the aforesaid tenth day of December Next the day the said Bowman the said Eight pound
Nine Shilling to the said William upon the aforesaid tenth day of December hath not rendered but the same hitherto
to render hath denyed and Still doth deny and Unjustly detain to the damage of the said William
of fifteen pounds money aforesaid and thereupon he brings Suite &c.
