set County Gentleman present in Court undertakes for the said Rob^t Makhum that if in Case the said Samuel
Handy shall Recover Judgment in the plea a^d against the said Robert Makhum or that the said Robert
Makhum shall be therein Convict that then he the said Robert Makhum shall pay the condemnation of the
Court thereupon or that he the said Lewis Gale will do it for him

Whereupon the said Robert Makhum by Lewis Gale his attorney comes and defends the force &
Injury whereof and sayeth that he cannot gainsay the pl^ts his action a^d, against him brought nor
can he say but that the bond or writing Obligatory a^d is his act and deed & that the debt therein
mentioned is yett due and unsatisfied wherefore the said pl^ts prayeth Judgment for his debt a^d and
his Costs and damages Sustained by Detention of the same debt

Therefore it is considered by the Court here the sixteenth day of March and Dow One thousand
Seven hundred & twenty four a^d that the said Samuel Handy Recover against the said Robert Makhum
as well the Sum of three thousand pounds of good sound merchantable tobacco his debt a^d as also the Sum
of four hundred & forty three pounds of tobacco for his Costs and damages Sustained
by Detention of the same debt to the said Samuel by his assent by the Court here adjudged
with Stay of Execution till death of November Next and the a^d Robert Makhum in Mercy
