

County planter present here in Court in his own proper person undertaken for the said Michael Holland that in case the said Lewis Denwood shall Recover Judgment in the pleafes against the said Michael Holland, or that the said Michael Holland shall be here in found that then he shall said Michael Holland shall pay the Condemnation of the Court there upon unto the said Lewis Denwood or tender his body to the custody of the Sheriff of Somerset County in Satisfaction thereof or that he of said Michael Holland Judg. will doe it for him &c —

Whereupon the said Michael Holland by George Darlie his attorney comes and defend the force and Injury wherein &c and says that he cannot gainsay the pleafes action aſt against him brought nor can he say but that the Writing Obligatory aſt is his act and deed and that the debt herein mentioned is yet due and unsatisfied wherefore the sum of the gray Judgment for his debt aſt and his costs and damages sustained by reason of the claiming of the same debt =

Therefore it is considered by the Court here the fifteenth day of June anno domini One thousand Seven hundred and twenty five that the aſt Lewis Denwood Recover against the aſt Michael Holland as well the sum of One hundred and Sixty pounds, Court money his debt aſt as also the sum of four hundred and Nine —
 (103) pounds aſt toſt for his costs and damages by reason of the claiming the same debt to the same Lewis Denwood of his agent by the Court here adjudged & the aſt day in May

L. G. John West - Somerset Esq: Patrick Daley late of Somerset County Labourer aſt did Patrick for Patrick Daley — Daley was summoned to answer unto John West of yeale that he tender unto him the sum of thirteen hundred and fifty pounds of tobacco which he did owe him & from him he ought to pay him &c. And whereupon the same John by Lewis Gale his attorney saith that whereas the aſt the eighteenth day of June seventeen hundred & twenty four at Somſet County aſt within the Jurisdiction of this Court by his certain Writing Obligatory granted himself to be held and firmly bound unto the aſt John in the aſt sum of thirteen hundred and fifty pounds of tobacco to be paid unto the same John when he should be afterward remitted required by the aſt Patrick altho' after required the aſt thirteen hundred and fifty pounds of tobacco to the same John as byt to tender hath denied & still doth deny whereby the said John saith he is worse & hath damage to the value of one hundred pounds of tobacco and there of he brings suit &c

And bring here unto Court the Writing aſt which he doth aſt wherein aſt doth testify whose date is the same day & year above said aſt Gale of Quay. Elizab. good Doe by her —

Whereupon the said Patrick Daley in his own proper person appears and thereupon the said Patrick Daley at the prayer of the pleafes attorney aſt is adjudged to give special bail to the action aſt. Thereupon a certain Richard Blenket of Somerset County Planter in his
