In Case they do not make their personall appearance before the Justices of the Peace Nisi prius, Oyer and Terminer and Goal delivery the first Tuesday of September Next to give Evidence on behalfe of his Lordship against the said William Robertson and not to depart the Court without License thereof

Whereupon it is ordered by the Court that John Davis Esq. of the County of Sussex upon Delaware & Philip Wingate of Somerset County give Security in the Sum of forty pounds Sterl. Each for their appearance before the Justices of the Peace Nisi prius Oyer and Terminer and Goal delivery at Dividing Creek the first Tuesday of September Next to give Evidence on behalfe of the Lord Proprietary against a certain William Robertson. Thereupon the said John Davis and Philip Wingate both present in Court acknowledged themselves to Owe and Stand Justly Indebted unto the Right honorable the Lord Proprietary of this Province his heirs and Successors in the Sum of forty pounds Sterl. Each, to be Levied severally on ^{their} goods and Chattels Lands and tenements for the Use of his said Lordship in Case the said John Davis and Philip Wingate do not make their personall appearance before the Justices of the Peace Nisi prius Oyer and Terminer and Goal delivery the first Tuesday of September Next to give Evidence on behalfe of his said Lordship against the said William Robertson and not to depart the Court without Leave thereof

Likewise a certain Thomas Jordan of Somerset County present here in Court as under takes for the said John Davis and Philip Wingate and acknowledged himself to Owe and Stand Justly Indebted unto the Right honorable the Lord Proprietary his heirs and Successors in the Sum of forty pounds Sterl. for each of them to be Levied on his Body goods and Chattels Lands and tenements for the Use of his said Lordship In Case the said John Davis and Philip Wingate do not make their personall appearance before the Justices of the Peace Nisi prius Oyer and Terminer and Goal delivery the first Tuesday of September Next to give Evidence on behalfe of the said Proprietary against William Robertson, and not to depart the Court without License thereof

His Lordship - Upon the Complaint of Lewis Gale Clerk of Inditments to this Court against a certain Edmund Huggins of Somerset County for his unlawful Prangning &c. whereupon the said Edmund Huggins present in Court is ordered to give security for his appearance at November Court Next - Thereupon the said Edmund Huggins acknowledged himself to Owe and Stand Justly Indebted unto his Lordship the Lord Proprietary his heirs and Successors in the Sum of fifty pounds Sterling to be Levied on his body goods and Chattels Lands or Tenements for the Use of his said Lordship the Lord Proprietary In Case he does not make his personall appearance before the Justices of the County Court of Somerset the third Tuesday of November Next to be hold at Dividing Creek, to answer unto his Lordship the Lord Proprietary concerning all such Matters and things as shall be then and there objected against him on his Lordship's behalfe and to stand and abide the Judgment of the Court
