his Security and acknowledged themselves to owe and Stand Justly Indebted unto the said John  
German in the Sum of forty pounds Sterl. on the body, Goods and Chattels, Lands and tenements jointly  
and Separately to be levied for the Use of the said John German In case he doth not learn him to  
Read well in the Bible, and the trade of a tanner and to give him a three Year Old heifer at the Expi-  
ration of his Servitude and to find him with good and sufficient meat drink washing Lodging and appa-  
rel meta for him to have and wear during his Servitude aforesaid &c
