Memorandum the Cth by Lewis Gale her attorney sued Out his Lordships Writ of Sicarfacias against the defth the tenor whereof followeth in these words viz.

Somerset County ff: Charles absolute Lord and proprietary of the provinces of Maryland and Avalon Lord Baron of Baltimore &c. To the Sherr. of Somerset County Greeting Whereas a certain Robert Martin lately in our County Court of Somerset to wit on the twentieth day of August in the eighth Year of our Dominion &c. and Died: One thousand Seven hundred and twenty three Before the worshipful Sir Charles Ballard Gent: and his associates Then Justices of our said Court at dividing Bench, and by Consideration of our same Court Recovered against a certain Edmond Huggins Ind, of Stapway Parish in Somerset County planter as well the Sum of Eight hundred pounds and seventy four pence of tobacco certain Damages as also the Sum of Seven hundred and fourteen pence of tobacco which
