Court to be hold at Dividing Creek in Somerset County at the third Tuesday of August Next then and there
to be condemned according to act of assembly to aid for the Use of a certain Joseph McCarter Sheriff of
the said County unless the said Jonathan Raymond by himself or attorney shall appear and answer unto
the said Joseph McCarter in regard of the said upon the Care &c. according to Law and that by good
and Lawfull men of your Bailiwick you make known unto the person or persons in whose hands
you make the same attachment that he she or they be and appear before the Justices of our said County
Court to be hold as aforesaid to shew Cause if any he she or they have why the same goods Chattels Rights
or Credits so attached in his her or their hands ought not to be condemned and Execution thereof had and made
according to the form of the act of assembly in such Cases made and provided if to him her or them it shall
seem meet and how you shall Execute this Writ that you make known to our said Justices at the same
